TRIP TO MAIL CENTER

BENEFITS OF PARTICIPATION (Part V)

The holding of property in joint tenancy between husband and wife may be convenient when total family assets are less than that amount which requires reporting to the government under Federal Estate Tax Regulations, currently \$650,000. In such a small estate, it may be theoretically possible for the couple to leave the estate to the surviving spouse without the necessity of having a will. By holding title to their assets in joint tenancy with right of survivorship, the assets pass to the spouse via that right recognized in Colorado. However, thought should be given to the event of a common disaster in which neither husband nor wife survive. Without a will, the assets will be distributed under provisions of Colorado law which may not be in accordance with their intentions, especially if there are surviving children since in a will the parents may name their preferences as to guardians, conservators, and/or custodians rather than the court delegating these tasks. The will can also establish trusts for the children.

A joint tenancy is a joint interest owned by two or more persons in generally equal shares where it is expressly declared that the title is held in joint tenancy. It is probably the simplest way of avoiding probate, but as will be seen, this form of title holding has numerous disadvantages. Outside of creation of joint tenancy ownership between spouses, a taxable gift may occur unless each joint tenant contributes equally. Additionally there are other reasons why joint tenancy may be inappropriate from an estate planning viewpoint.

First, such property cannot be passed by the will of the joint owner dying first. Circumstances may change and either owner may wish to leave the asset to someone else, or either owner during their lifetime may dissolve the joint tenancy. Second, from an income tax point of view, joint tenancy property at death only receives an adjusted basis to the percentage of ownership held by the decedent. Third, such ownership limits post mortem planning especially

in larger estates. Fourth, the property may be subject to attack from creditors of an individual joint owner.

Tenants in common differs from joint tenancy ownership and should not be confused - it is easy to do. In joint tenancy, you and your spouse both own the whole house, which among other things means you must both agree to sell it. In tenants in common, on the other hand, you each own a half share of the house and either of you can sell your share without the consent of the other. Further, if you own an asset in joint tenancy with anyone and you die, ownership of that asset passes to the other joint tenant automatically. Tenants in common, your share passes as provided in will or trust with possible probate and other consequences.

Life estates are a different vehicle of estate planning. An older couple may choose to assign the family home to children who have expressed an interest in living there after the parents have died. The parents retain what is referred to as a life estate interest in the house meaning that they have a right to live there until they die, and then the property reverts to the children. Another method is to leave the children a life estate in family property. The children can use or rent it but are responsible for it being kept in good condition. Upon the children's death, the property can pass to grandchildren. Transferring property via life estates is subject to complex legal and possibly tax rules and often may create more complications than wanted. Check with your attorney and seek his/her assistance.

The RMPL received a nice write-up in the July 13, 1998 issue of Linn's Stamp News. This was written by Rich Wolff who visited the library during ROMPEX. He thought the library was nice, but what intrigued him was how we accomplished all that was necessary to make it a reality so that was the main thrust of the story. Since the publication, we have had many requests for further information, membership applications, and letters offering materials. All of these are most welcome. We take this opportunity to thank Rich and Linn's for such a good write-up.

My first trip out to the site was nearly two years ago for a meeting of the ROMPEX Committee. Useful Tools

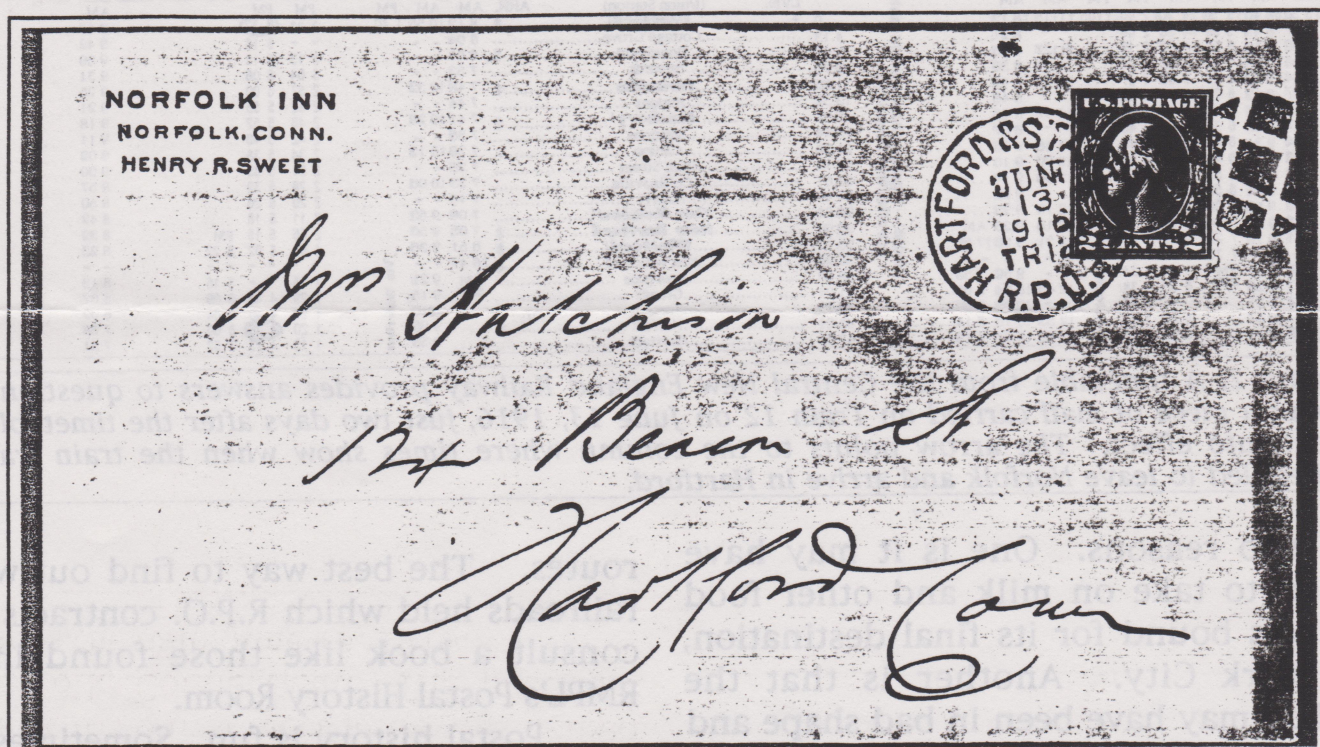


Figure 1. A cover like this one that is very simple in appearance can provide a wealth of information to stamp collectors who are interested in postal history.

Many useful tools may be found in the Postal History Room at the Rocky Mountain Philatelic Library. Let's use the cover shown in Figure 1 and see what can be learned.

According to the neatly printed corner card our subject letter was mailed in Norfolk, Connecticut. The postmark provides the date, June 13, 1916.

You want to know more about Train #12 and the railroad it ran on. The library shelves can supply a 1916 edition of "The Official Guide of the Railways and Steam Navigation Lines of the United States." If you look up Norfolk, Connecticut in the index you will find it is served by the Central New England Railway. If you then look up the railway you will find the

The letter is addressed to Hartford, Connecticut. How will it get there?

The postmark also tells us the envelope was picked up, probably from a letter box on the Norfolk Railroad Station platform, by a railway mail clerk from Train #12, Hartford & State Line R.P.O. (Railway Post Office). You know that because there is no postmark from Norfolk.

schedule of Train #12 (Figure 2).

Let's play like the train was on time and discover that this letter was picked up at 4:36 pm and arrived at its destination, Hartford, at 6:32 pm.

The 45.61 mile trip from Norfolk to Hartford took one hour and 56 minutes. It averaged about 23 miles per hour. We can speculate that the train was so slow for at

least two reasons. One is it may have paused to take on milk and other food products bound for its final destination, New York City. Another is that the roadbed may have been in bad shape and to avoid derailments, the train went slowly.

At a later date this railroad became a part of the New York, New Haven & Hartford Railroad.

You may notice that the cancel, from the Hartford & State Line R.P.O., is not the same as the name of the railroad, the Central New England Railway. This is because the Central New England had a contract to carry mail for the U.S. Post Office, and the Post Office named its R.P.O.

routes. The best way to find out which railroads held which R.P.O. contracts is to consult a book like those found in the RMPL's Postal History Room.

Postal history is fun. Sometimes it is like "Trivial Pursuit," but you always come away with knowledge of something you were searching for. If it was something you wanted to know, it was not trivial.
